The principal in elementary school as a leader in an educational institution organization in Indonesia has a very strategic role. The purpose of this study was to determine the leadership responsibilities of the principal of Elementary School 1 South Tangerang to education reform, especially in Indonesia. Abstrak

Indonesian education provided by the school is a science given to be able to provide direction and goals to each student in the hope that students can grow and develop and be able to adapt to the social environment because each region has its environment (Triwiyanto, 2021). It is hoped that every student will be able to adapt wherever they are. Education Unit Level Curriculum gives freedom to each teacher to determine the curriculum needed in each student and pay attention to the characteristics that each individual has and is not forgotten the environment in which they carry out the educational methods applied.

Because this curriculum has been adopted for quite a long time and is not by the developments that are happening at this time, a new curriculum is formed and implemented, namely the 2013 curriculum where this curriculum emphasizes how the character education of each student is formed, the skills needed to enter the community environment, the ability that each student has to understand every material given, the ability to present to be able to manage the public speaking skills of each individual, and have good manners because in this era everything goes very fast so that it is felt that there is a lack of filtering that can be done to the culture that enters Indonesia so it is hoped that with this curriculum, every student can have manners that are by the identity of the Indonesian nation.

This is reflected in elementary school 1 South Tangerang, with various facilities obtained by students including teachers, providing their points and positive values for the progress and quality of educational institutions. Leadership qualities not only provide good learning media but also pay attention to the welfare of teachers. Especially in the era of education that is increasingly progressing, it is necessary to be conditioned by the situation and location of the school. So it will appear that a good and quality school depends on how the principal leads.

According to the view of Somantri (2014) that to achieve a good quality of education, various factors can be the reason, one of which is good school management. When it comes to the management carried out by the school, of course, the principal has an important role in it to achieve the goals expected by the school in shaping the nation's generations to be molded into a generation that is intelligent and useful for the nation and state. Nature's efforts to achieve good quality are carried out renewal, especially in the field of education. According to (Madya, 2012), it is known that there are proposals related to education, namely in the learning process, the grounding process is carried out. This process explains that to give every young child the opportunity for them to live their life which is still sacred because they are still young every child can keep up with the development and growth they should get because it is their basic right to be able to receive basic education during the 9 years of schooling in Indonesia.



Therefore, a school principal with good quality and capability can certainly increase the possibility of a school having good educational standards by improving its education system or the facilities provided or also good quality Human Resources.

Examples that can be done by the principal carrying out his role by quoting from Supanda et al. (2019) there are several examples, namely:

- 1. Activities that take place in schools are arranged in such a way that they can run effectively and efficiently
- 2. Providing briefings to each coach and teacher and conducting appeals with various other educational institutions to improve the quality of both teachers and coaches in the school
- 3. Improving the discipline possessed by students such as creating programs that are expected to be able to improve and build the character of each student
- 4. Adding hours outside of school hours to support programs that are expected to improve and shape the character of each student
- 5. Work with various agencies to be able to support programs that aim to improve and shape the character of each student
- 6. Provide additional literacy to be placed in the library and familiarize each student with reading the literacy in the library
- 7. Develop harmonious relationships between staff in the school environment and form a good relationship between the school and the surrounding community.

In addition, to improve education by supporting changes in education, a school principal has many functions, including quoting from Fitrah (2017) are principal as an educator, principal as a manager, principal as administrator, principal as supervisor, principal as a leader, principal as an innovator, the principal is a motivator.



Character education which is an effort in the latest curriculum for the renewal of education in Indonesia today is based on Hamdani (2019) that character education has the aim of shaping every character of the generation of the Indonesian nation who are more moral, producing the nation's youth who are smart and have a rational mind, can innovate and work hard, have a patriot spirit, be optimistic and much more so that changes are needed in the era of education that towards an education that can apply character education to every child of the nation so that every student can strive and maximize what is the basic advantage (Mansir, 2021).

The education system that exists in one school with another often has a quality that is not much different. But of course, each school always has its advantages of the vision and mission made by the principal or the results of deliberations from the principal and other devices (Goff et al., 2014). The renewal of the education system is of course also needed by each school to maintain quality and also so as not to be less competitive with other schools. The renewal of the education system often starts with the idea of a qualified and capable school principal (Al-Safran et al., 2014). The existence of this update can later correct the shortcomings that existed in the previous system which may be felt to be less than optimal or there are many shortcomings in several aspects.

If it is likened to it, then the principal is a captain of a ship that sails the vast ocean. Where this ship is going, of course, the decision is in the hands of the skipper who leads, this is the same as in the school, where the direction of educational or non-educational renewal in a school is of course held by the principal (Ibrahim & Al-Taneiji, 2015). A good skipper will direct the ship towards the destination with good technicalities and not harm his subordinates, as well as a good principal, will direct the renewal of education in his school without causing any losses in the surrounding environment and or even helping the surrounding environment to grow and develop in the future (Hauserman et al., 2013). The direction of education renewal can be seen from various aspects that exist. One of them is the curriculum used in the school, if the curriculum used in a school still uses the old curriculum that does not meet the standards, it will be highly recommended to update the curriculum for the good of the school or students studying at the school (Pina et al., 2015). In addition to the curriculum, educational updates, one of which can be carried out in the facilities provided by the school, for example, the availability of adequate science laboratories, computer laboratories with the latest equipment, comfortable libraries, clean canteens, quality classrooms, and sports fields that are by standards.

This adequate laboratory will make it easier for students or teachers who want to do research or just do a practicum to meet subject scores. In addition, the availability of adequate laboratories can also increase the accreditation of the school which can improve the overall school ranking. Computer laboratories that use the latest devices can also considerably influence educational renewal. In today's age of globalization, it is easier for students to find information through the internet where almost everything they are looking for can be found there. This computer laboratory can also help students learn how to use several software programs that will later be used in the world of work and their daily lives. This convenient library can later make it easier for students to find information in the library collection books. In addition, improving the quality of the library also means expanding the existing collection of books so that students will have more references. A library with a calm atmosphere can also provide tranquility for visitors who may be looking for a place to refresh for a while from the boring atmosphere of the classroom. The availability of a clean canteen can also support the renewal of education in a school, with a clean canteen condition accompanied by serving healthy and nutritious food so that it can provide adequate nutritional intake for its students. In addition, a clean canteen can also have a good impact, such as reducing the risk of students buying food outside the school.

This quality classroom can provide a sense of comfort to students when carrying out teaching and learning activities, with this students can focus more on absorbing the knowledge gained from the teacher. In addition, the availability of projectors and speakers can also be useful for teachers to deliver material in other ways besides explaining conventionally, such as using attractive presentations, animated videos, games, or films. Not to mention that sports fields that are by standards can also improve educational renewal, where not all students like academic lessons, and there must be some students who prefer non-academic lessons such as sports. Therefore, schools should provide adequate facilities to maximize the potential of their students so that it will increase the opportunity to make the school proud in existing competitions.

Teaching staff who can creatively deliver lessons are needed so that students do not get bored easily during the lesson. In addition, using unconventional methods in teaching also increases the creativity of its students. In this era, teaching using conventional methods is no longer considered ineffective. Apart from making students get bored quickly and not paying attention to the lesson.

But that does not mean that conventional methods should not be used in schools, conventional methods should still be used in schools but combined with non-conventional methods so that there will be no sudden changes (Wasserman et al., 2016). This combination of methods allows for accelerating the renewal of education in schools which stems from the important role of the principal as the 'skipper' of a school. Although the principal plays an important role in the renewal of education in a school, the environment and human resources are also important in the process of implementing educational renewal in schools. This renewal of education is very important for every school. Each principal should also be given training on educational renewal so that later it can be implemented in schools within the city or national scope. The progress of this education renewal is also one that is accounted for by the principal to the Minister of Education so that each school will later have approximately the same educational standards.

If each school has more or less the same educational standards, then every student who studies there will receive knowledge equal to or even the same as each other (Mansir, n.d.). From here, it will be created in the world of education where every student gets the same quality of learning without the need to look at the existing social status, later it is hoped that all students will be able to receive the same knowledge with the same facilities and the quality of teachers is more or less the same as well (Kaso et al., 2021). Starting from the role of the principal in updating education in his school, can affect the equal rights of every Indonesian citizen to get a decent education of good quality (Mansir, 2021). With this, the standard of learning in Indonesia is expected to increase and can be a turning point in the rise of Indonesian education to always improve and provide the best for students or for teachers who devote themselves to the future of futures of the nation's bright successors and can compete with other countries in Asia or the World.

Conclusion

The leadership of the principal in educational institutions in Indonesia has a very strategic position because he can determine the direction of school policies and put the school's position at a better level and standard. The performance of the principal with his leadership attitude contributes greatly to determining the quality of the educational institution.
